- A. Received Monthly Financial Statements for Biscayne High School through August 31, 2020
- **B.** Received Monthly Financial Statements for Lone Star High School through August 31, 2020 Mrs. Kerns discussed the financial statements presented through August 31, 2020 for Biscayne High School and Lone Star High School. Both schools are waiting on PICO funds from the schools. Overall, both schools are in a good financial position coming into the 2020-2021 school year.

The Board received the financial statements through August 31, 2020 for Biscayne High School and Lone Star High School.

- D. <u>Approved</u> 2020-2021 Lone Star High School Budget Amendment Ms. Baldree discussed the presented budget amendments for Biscayne High School and Lone Star High School. FTE projected budgets have been reduced – Biscayne reduced from 185 to 175; Lone Star reduced from 225 to 200. Both school received special revenues in Title grants and Cares Act grants. In both budgets, we have included the revenue funding received for the Cares Act grant, ACT/SAT grant, Title I/II/IV and the teacher salary increase.

**B.** Biscayne Principal's Report

Highlights include:

- Student survey sent out last week to see if students would like to continue working virtually or come into the building.
- We received a reduction in funding; the District used the 10-day count to fund schools.
- Currently, we are having structural issues; thank you John Fuller for your assistance in trying to rectify the situation.
- We have done a technology refresh in one of our classrooms.
- Course Completion numbers and attendance rates are up; congratulations students!
- We received our Charter Renewal timeline; we have begun gather information and data.
- C. Lone Star Principal's Report

Highlights include:

- I made some home visits during FTE period; during visits, parent concerns were addressed.
- With regards to funding, we need to sustain until we receive the funding.
- We have had some student incentives to re-engage inactive students.
- We have done a technology refresh in two of our classrooms.
- We lost a teacher, Mr. Parsons, he lost his battle to cancer. He will truly be missed.
- We are encouraging our parents/students to come back to the building for class for those who need face-to-face instruction.

Highlights include:

- Biscayne Baseline Data Math at sixth grade, seventh month; Reading at sixth grade, one month. Participation rates Math 82%, Reading 84%
- Lone Star Baseline Data Math at sixth grade, eighth month; Reading at sixth grade, eighth month. Participation rates Math 24%, Reading 27%
- E. NEWCorp Florida Update

Highlights include:

- Audits submitted on time 9/30/2020!
- \$108,189.00 debt forgiveness for Biscayne from NEWCorp.
- \$40,009.00 debt forgiveness for Lone Star from NEWCorp.
- NEWCorp sends our deepest condolences to Lone Star faculty, staff and students on the passing of Mr. Parsons.
- Biscayne has a Charter Renewal this year and a tax exemption renewal.
- Cognia Accreditation process has begun for all schools.

Ms. Baldree explained that the teacher salary schedule for both schools were revised to include the allocation received to increase classroom teachers' salaries to a minimum base salary of \$47,500.00. Increases will be retroacted to July 1, 2020 once Duval County Public Schools gets State approval.

On a joint motion from Brandon McCray and seconded by Tameiko Grant, the Board unanimously approved the Revised Teacher Salary Schedule for Biscayne High School and Lone Star High School.

C. <u>Approved</u> Out of Field Waivers for Lone Star High School Mrs. Evans discussed the Out of Field Waiver request presented. The request for approval is for Mrs. Washington for English Language Arts; Mrs. Sapp for World History, American History., US Government and Economics.
