- **D.** DOE Data Update

Highlights include:

- Numbers for both schools will be skewed due to virtual learning
- Biscayne: 60% of students who participated in Math growth assessment met the growth target of two years in one academic year. 48 % of students who participated in the Reading growth assessment met the growth target of two years in one academic year.
- Lone Star: 59% of students who participated in Math growth assessment met the growth target of two years in one academic year. 45% of students who participated in the Reading growth assessment met the growth target of two years in one academic year.
- E. NEWCorp Florida Update

Ms. Baldree informed the Board that the State of Florida sent out a 143 page Re-Opening guide. NEWCorp will be having a meeting with Principals next week to discuss the guide.
