#### C. Lone Star Principal's Report

Highlights include:

- We are continually exposing the students to opportunities; we will have our students participating in an internship that can led to a permanent position.
- We have given the ASVAB practice test to prepare students to take the ASVAB and meet withal the branches of military.
- Love Notes, a state funded program, comes out weekly to work with students on social and economic topics.
- We are closing out graduates daily and providing motivation to students who are close to completing their graduation requirements.
